Regular Meeting
April 10, 2014

Dallas Grewe called the meeting to order at 7:00 PM. The following members were present: Kevin Anderson, Craig Bengtson, Dallas Grewe, Treasurer Linda Nelson and Jan Eitzen. The board recited the Pledge of Allegiance.

Eitzen presented the mail for board review.

Motion by Anderson to approve the March Treasurer's Report as printed. Second by Bengtson. The following voted for: Anderson, Bengtson, Grewe. Against: None. MCU

Motion by Bengtson to approve paying check numbers 5041 – 5055 in the amount of \$7,631.60 and additional checks for Cline for \$1815.00. Second by Anderson. The following voted for: Anderson, Bengtson, Grewe. Against: None. MCU

The board received a petition to pave 380th Ave from Highway 210 to Front Street (Lakewood Cemetery). The petition contained 6 signatures. The board discussed expenses. No further action will be taken.

The board discussed chloride treatment options. Motion by Bengtson to reimburse \$.10 a foot toward treatment for each resident who submits an invoice. Bengtson amended his motion to reimburse \$.20 a foot toward treatment for each resident who submits an invoice. 2nd Anderson. MC

The board hosted a video conference with Troy Gilchrist, attorney supporting the zoning policies. Gilchrist asked the board several preliminary questions.

Bengtson gave the Motor Patrol Report. Motor Patrol looking at a truck tomorrow, 9:00 am. Grewe will plan to go along to look at the truck.

Anderson gave the Fire Report.

The board received a quote from Donoson Grewe and Larris Grewe for brushing. Motion by Bengtson to hire them for brushing, but no work can start until the Certificate of Insurance is received by the clerk. 2nd Anderson. The following voted for: Anderson, Bengtson, Grewe. Against: None. MCU

The board posted the gravel and mowing specs for 2014 in the Battle Lake Review. A quote from Dennis Borgos was received for mowing and a quote for gravel was received from Earl Strande.

The board scheduled a road inspection for Wednesday April 30, 2014 at 5:00 p.m. Meet at Battle Lake City Hall.

A resident complained about the gravel in the ditches. The board will look at it during the road inspection.

A resident asked about the land purchase agreement referred to last month. Bengtson clarified that the purchase agreement was refused by the seller as they would not agree to the township's terms.

Eitzen read the minutes. Motion by Bengtson to approve the minutes. 2nd Anderson. MC

Motion by Anderson to recess until Friday, April 11 to look at a truck and further recess to April 30 for the Road Inspection. Second by Bengtson. The following voted for: Anderson, Bengtson, Grewe.
Against: None. MCU. The meeting recessed at 9:15 PM.
